

# NCSCA Delegate Assembly 2021

## What is it?

The delegate assembly is a meeting of selected school counselors from across the state of North Carolina who are brought together to discuss trends in school counseling profession, North Carolina specific school counseling issues such as advocacy on the local and state level, and NCSCA organizational matters. The delegate assembly membership may be tasked with casting certain votes before it is taken to the general NCSCA membership, or with providing direction or feedback on specific decisions being considered by the board of directors. See specific wording from by-laws below:

<b>ARTICLE VII, SECTION 3</b>	<b>Composition and Selection of the Delegate Assembly</b>
VII-3a.	The Delegate Assembly shall be composed of voting members of the Board of Directors of NCSCA and delegates of the regions as described in NCSCA policies that address delegate representation.
VII-3b.	Regional delegates shall be selected in any manner that a Division chooses; however, delegates must be Professional or Retired members of NCSCA.
VII-3c.	A Region shall submit to NCSCA's manager the names and addresses of its delegates to the Delegate Assembly.

<b>ARTICLE VII, SECTION 4</b>	<b>Functions of the Delegate Assembly. The Delegate Assembly shall be the highest legislative body of NCSCA.</b>
VII-4a.	The Delegate Assembly shall identify and present current issues, trends and concerns that affect or may affect professional school counselors and their students;
VII-4b.	The Delegate Assembly shall act on recommendations from the Board of Directors, committees and task forces;
VII-4c.	The Delegate Assembly shall grant or deny applications for the formation of new chapters; and revoke charters that may previously have been granted to chapters, following due process as set forth in NCSCA's policies that address local chapters;
VII-4d.	The Delegate Assembly shall exercise such other functions as may be in the best interest of NCSCA, not in conflict with the By-Laws.

<b>ARTICLE IX, SECTION 1</b>	<b>Meetings of the Delegate Assembly</b>
IX-1a.	The Delegate Assembly shall meet annually in conjunction with the NCSCA annual conference. Additional meetings may be called by majority vote of the Delegate Assembly or the Board of Directors.
IX-1b.	Two-Thirds of the members of the Delegate Assembly must be present to constitute a quorum.
IX-1c.	Each member of the Delegate Assembly shall have one vote. Decisions of the Delegate Assembly shall be made by a simple majority vote except in cases involving issues that require a greater majority, as defined in these By-Laws and NCSCA policies that address governance.
IX-1d.	Meetings of the Delegate Assembly shall be conducted in accordance with standing rules adopted by the Delegates.
